The Applicant further agrees that if this Application is accepted, Genesis Integration Inc. may refuse to extend credit, or may reduce the amount of credit previously extended, at any time without providing reasons for such refusal or reductions; furthermore, Genesis Integration Inc. assumes no liability for instituting such action. Upon request, the Applicant and/or its principals will provide a guarantee or other security acceptable to Genesis Integration Inc.

The Applicant agrees that if it is claiming a tax-exempt status, a tax exemption certificate will be provided to Genesis Integration Inc. The Applicant agrees that if it is an unincorporated business that is incorporated at a later date, it will notify Genesis Integration Inc. in writing within 14 days of such incorporation.

Unless otherwise specified on invoices and statements sent from time to time by Genesis Integration Inc. to the Applicant, the terms of sale are due upon receipt of the invoice. The Applicant agrees to pay interest in the amount of 2% per month (24% per annum) on all past due amounts. The Applicant agrees to pay Genesis Integration Inc. all costs, charges and expenses (including, without limitation, legal fees and expenses) incurred by or on behalf of Genesis Integration Inc. in connection with the collection of any outstanding amounts and/or the enforcement by Genesis Integration Inc. of any of its rights against the Applicant. Invoices and statements will be considered correct by both parties unless Genesis Integration Inc. is notified, in writing, of any errors within 30 days of invoicing.

Title to all goods sold or delivered by Genesis Integration Inc. will remain the property of Genesis Integration Inc. until such goods have been fully paid for by the Applicant and Genesis Integration Inc. shall have a continuing security interest and purchase money security interest in all such goods and their proceeds to secure payment by the Applicant of all its obligations to Genesis Integration Inc.

The Applicant consents to Genesis Integration Inc. obtaining and disclosing credit, personal or other information about the Applicant and/or its principals for the purpose of determining whether to extend credit to the Applicant (the "Purpose"). The Applicant represents and warrants that the Applicant has the authority to grant such consent on behalf of its principals. Genesis Integration Inc. may obtain such information from, or disclose such information to, any credit reporting agency, credit bureau, collection agency, personal information agency, financial institution, bank, any party with whom the Applicant or principals have had or may have financial relations, or any other party on a need to know basis for the Purpose. Genesis Integration Inc. shall keep such information as long as is necessary for the Purpose or as required by law. The Applicant acknowledges that if it withdraws this consent at any time, Genesis Integration Inc. is under no obligation to extend, or continue to extend credit.

The Applicant acknowledges receipt of a copy of this Application.
